## 11. Proposed Constitution amendments

The primary driver for updating the NZ Young Farmers Constitution is to ensure compliance with the new Incorporated Societies Act. To meet the re-registration deadline of 5 April 2026, we must align our Constitution with the updated legislation. This process also provided an opportunity to modernise the Constitution, clarify grey areas and remove any unnecessary administration.

Following an initial review by the Board and National Office, the National Committee participated in a workshop in May, where members provided feedback on proposed changes and had the opportunity to suggest further amendments. A draft constitution was then developed and reviewed by a lawyer.



To ensure the revised Constitution reflects the needs of our members, we ran a formal consultation period from 23 June – 24 August. Members were able to review all proposed changes via a dedicated landing page, which included detailed explanation for each change proposed. To encourage member engagement, reminders were sent through email and our social channels to members and committee members.

Six members provided feedback through this process, and their input directly informed amendments to the draft. A full summary of member feedback and subsequent changes is available on the <u>landing page</u>.

This robust consultation process has ensured members were actively engaged in shaping the proposed Constitution. This replaces the need to review each clause individually at the AGM. Instead, representatives from each region will be asked to vote on the Constitution as a complete document.
